Minutes - Nassington Parish Council Meeting

Wednesday 9th September 2020 via electronic communication in a virtual setting at 7.30 pm BST

In accordance with provision laid down by The Local Authorities and Police and Crime Panels (Coronavirus) (Flexibility of Local Authority and Police and Crime Panel Meetings) (England and Wales) Regulations 2020, during a period of encouraged 'social distancing', this meeting was held by means of internet video and telephone communication in a virtual setting, using Zoom software. All members were always able to hear proceedings and members of the public had been given opportunity to attend.

20/1930 ATTENDANCE AND APOLOGIES FOR ABSENCE:

Present: Cllr Alan Burns (Chairman) Cllr Tony Cooper, Cllr Dec Downey, Cllr Robert Peterson and Cllr Ruth Rigby. Apologies were received from Rebecca Downey due to personal commitments and Paul Monks and Susie Tinsley due to business commitments. It was resolved to accept these apologies. Officer present: The clerk.

20/1930 DECLARATIONS OF INTEREST:

Cllr Peterson declared personal non-pecuniary interests in the planning matters to be discussed.

20/1931 MINUTES:

It was resolved to approve the minutes of the June 2020 meeting as a proper record of that meeting. The chairman will sign the minutes at an appropriate time.

20/1932 Address From Members Of The Public:

There was none.

20/1931 PLANNING AND DEVELOPMENT MATTERS:

- a) 20/00863/FUL | Siting of timber framed garden building for use as ancillary living accommodation (granny annexe) | 2 Parkway Nassington. It was *RESOLVED* that the council has no objections or further comment to make.
- b) 20/00821/FUL | Extension to the side of the dwelling, an addition to the 20th century element of the dwelling; Aesthetic improvements to the exterior of the dwelling including new heritage windows, new painting of external elements and replacing brick construction with stone. | 46 Station Road Nassington. It was **RESOLVED** that the council has no objections or further comment to make.
- c) 20/00822/LBC | A new extension to the side of the dwelling, an addition to the 20th century element of the dwelling; Aesthetic improvements to the exterior of the dwelling including new heritage windows, new painting of external elements and replacing brick construction with stone; Minor alterations to internal layout and the rebuilding of broken staircases to the 2nd floor. | 46 Station Road Nassington. It was **RESOLVED** that the council has no objections or further comment to make.

20/1932 NATIONAL / LOCAL PLANNING ISSUES:

- The government white paper on planning reform was noted in terms of how it could affect the parish
 council's aspirations, although it was still 'early days' and a precis dissemination will be circulated when it
 is received, for further consideration of the matter at October's meeting.
- It was agreed that the Chairman plus two from Rob Peterson, Dec Downey and Tony Cooper would make
 up a working group. They will speak with three planning consultants from which one will be appointed to
 promote the council's current strategic plan to East Northamptonshire Council and carry out professional
 assessment of likelihood of success.
- It was **RESOLVED** to have Nassington parish area designated as a neighbourhood plan area.
- It was agreed that the working group as outlined above will meet with potential specialist neighbourhood planning consultants to partner a parish council led Neighbourhood Development Plan working party in developing a Neighbourhood Plan for Nassington, with primary focus on the allocation of land for development of new community facility (village hall, play area and muga).

20/1933 COMMUNITY MATTERS / PROJECTS:

- The resignations from the hub group were noted. The hub group has been paused for the time being. Once
 planning in terms of the local plan, the government white paper, the local government reorganisation and
 the input of planning consultants becomes a little clearer, there may be a necessity to reinstate the goup.
- Resident led defibrillator project: The chairman gave a brief outline of an approach made by a resident Nassington family who are very keen that each person in the village is within 500 metres of a defibrillator. They have bought a unit that is sited on the side of their house. The intention is that there will be at least seven in the village. A request has been made for public contributions for the next unit, which will be sited in the red phone box at the junction of The Drove and Apethorpe Road and if the monetary target is reached, the promotors will purchase a next one, bringing the total in the village to four (including the one at the village hall already in situ). It was **resolved** that the council supports this initiative completely, will be happy to take on ownership / responsibility and insurance liability. It was further resolved to allow installation in the phone box and to purchase a set of "defibrillator" signs to replace the "telephone" ones therein.
- Update on benches and noticeboard: Generally speaking, the benches have been well received by those
 using them, especially as they offer respite to people who may need a short rest whilst exercising. One of
 the benches has not been sited as originally agreed and has caused an issue as it is close to a residential
 setting and has the potential to attract a nuisance factor. It was agreed that the clerk would circulate a map
 of potential sites and a decision made at the October meeting.
- History group update: Physical meetings have not taken place due to current coronavirus restrictions. The
 project has been continuing in the background, with a website having been prepared and social media
 preparation in hand. Individuals are scanning heritage documents for digital storage. The current socioeconomic situation, worldwide, caused by the Covid19 pandemic has had an impact locally which has been
 captured for future historians as part of the project. The council recorded its endorsement for the project
 and willingness to offer practical support going forward.
- Village hall update: The trustees are investigating the possibility of re-opening the hall in line with the
 Covid19 restrictions lawfully prevalent at any given time should demand necessitate. In the short-term,
 the village hall is required until the new community hub project comes to fruition. In order to offer suitable
 premises, the trustees are investigating maintenance works plus some improvement works, in particular
 the windows and possibly men's facilities.
- Nassington Newsletter There is a requirement for new officers and an editor. The clerk will work with the remaining committee members to look at alternatives, including an online possibility, and advertise for an editor.
- Pocket park an enquiry had been received regarding maintenance of the area. It was agreed that a
 working party would be organised to clear the area over a weekend in the autumn. The area will be added
 to the village amenity grass-cutting schedule. The area will also be considered for a new bench.
- Stepping stones / crossing over river Nene backwater. It was agreed to make formal representation to Cambridgeshire County Council as highway authority to reinstate a crossing over the backwater in line with the definitive map.
- Pathway between green and playing field: The indicative quote received demonstrated that the project requires a formal tender with various options that would offer various cost options.
- **20/1934 GOVERNANCE MATTERS:** The internal auditors report had been received and circulated. It was resolved to note the contents and implement as part of the minuting process.

20/1939 LIGHTING TENDERS

In response to invitation to tender for replacement of parish streetlighting with LED fittings, three of the five companies approached submitted acceptable tenders. It was resolved to appoint Zeta Lighting as the council's partner for this project. It was agreed that the clerk and Rob Peterson would meet with the supplier and look at each light setting individually. The clerk will work with Zeta to submit energy saving data to Salix, the government's funding managers for this project, in order to ascertain funding available to borrow interest free.
